Thank you for your interest in the Imperial Valley College International Student Program. You will find that the following information will outline the admission requirements, deadline dates and other important relevant information.

Imperial Valley College is a two-year California community college located in the desert 120 miles east of San Diego and 15 miles north of Mexicali, Mexico. The Imperial Valley is one of the most productive and largest agricultural areas in the United States. The temperatures are mild in the winter and hot in the summer. The College awards two-year Associate of Arts and Associate of Science degrees.

APPLICATION DEADLINES:

All application materials must be on file by the following dates.

NEW STUDENTS:

Fall: June 1

Spring: November 1

TRANSFER STUDENTS:

Fall: June 1

Spring: November 1

NOTE:

International students are ineligible to begin their studies at Imperial Valley College in the Summer term or Winter intersession.

ADMISSIONS REQUIREMENTS CHECKLIST:

- ☐ High School diploma and transcripts or High School diploma equivalency (12 years of schooling) with a minimum grade of "B" or a 3.0 grade point average in a 4.0 scale.
- ☐ Official minimum score TOEFL IBT (min. 56), TOEFL ITP (min. 483), IELTS (min. 5.5), or DUOLINGO (min.85).
- ☐ 300 to 500 word handwritten personal statement stating your educational goals and why you would like to attend Imperial Valley College.
- ☐ Passport, Visa, I-20, I-94, and/or other non-immigrant status.
- ☐ Financial Statement Form.
- ☐ Bank Certification Form.
- ☐ Certificate of Sponsorship Form.
- ☐ Dependent Information Form. (Only if spouse and/or minor children are traveling with you)

Students must provide proof of adequate financial resources to pay all expenses attending Imperial Valley College before being admitted. Students are also required to provide proof to the United States Consulate when applying for a student visa. Documentation must be in the form of bank statements or certification by an official of the bank(s) showing sufficient funds in United States dollars.

If you will be bringing dependents with you to the United States, you must also provide proof of adequate support for those dependents. Additional estimated costs are \$3,600 per dependent.

NOTE: The form must be completed in full and provide documentation in English for the application to be considered. Bank statements or certification in currencies other than US dollars will not be accepted.
