### Question 1:

- What happens to already submitted proposals?

- Please resubmit the proposal documents noted above. A complete resubmittal of the entire original RFP package is not necessary.
- One (1) electronic copy of the resubmitted materials is required.

#### **Question 2:** What are the weekend hours?

**Answer 2:** As noted in Section I of the Supplement/Addendum No. 2:

Weekend hours are Friday night from 9:00 p.m. through Monday morning at 6:00 a.m.

Question 3: To confirm: the (2) guards are for the entire week, including the weekend?

**Answer 3:** Two (2) security guards will be required **AT THE SAME TIME** on the IVC campus for all service hours.

### Question 4:

- Does the District still require the eleven (11) hard copies as specified in the RFP instructions, along with an additional copy on a USB flash drive.
- Could the District please specify its preference for receiving the materials: via regular mail or email?
- Do we still need to print out 1 copy and have 10 copies of the proposal form and put it in a USB drive?
- Would you prefer to have the responses emailed or mailed out to you?
- Could you please specify the number of copies you require?
- Are we allowed to submit the revisions from 10 to 12 hours at the LLC via email or does this have to be sent in a sealed envelope?
