A background check and drug screen will be required if admitted to the program. **Failure to disclose this information (including expunged convictions) will disqualify the applicant, or cause dismissal from the Nursing Program.** The IVC Nursing Program does not make a determination whether a student with a past history of criminal activity should or should not apply.
